Registered Shooting Memberships By-law

1. AUTHORITY

- (a) This by-law (**By-law**) is expressly made as a By-Law of Australian Clay Target Association Limited (the **Company**) under clause 21 (By-Laws) of the Company's Constitution (**Constitution**).
- (b) This document:
 - (i) establishes the framework by which individuals are offered, and granted, membership of the Company as a Registered Shooting Member.
 - (ii) is subject to the Constitution;
 - (iii) is consistent with the Constitution; and
 - (iv) when in force, is binding on all Members and has the same effect as a provision in the Constitution.
- (c) The interpretation of this document is solely the province of the Board.

2. PURPOSE

The purpose of this By-law is to establish and detail the framework by which individuals are offered, and granted, membership of the Company as a Registered Shooting Member. This includes the provision of different categories of Registered Shooting Member and provision for renewal of those memberships. If this By-law is considered not sufficiently detailed for those conducting an election, those persons are to refer all questions of clarification or amplification to the Board of the Company.

3. CATEGORIES OF REGISTERED SHOOTING MEMBERS

3.1 Categories of membership

The following categories of Registered Shooting Memberships may be offered by the Company, the Member States and Clubs:

3.2 FULL ADULT MEMBER

3.3 PARTNER MEMBER

(Partner to a Full Adult Member at the same common address)

3.4 VETERAN

In line with pension eligibility, veteran status is available the next membership year after being eligible to obtain the age pension age

3.5 CONCESSION/LOYALTY

30yrs continuous Full membership

3.6 JUNIOR MEMBERS

Under 18 years at 31 December of the year of membership
(Date of birth must be supplied)

3.7 NEW START

Open to NEW members only for a period of one membership year to shoot competitively at members' HOME club ONLY.

3.8 RECREATIONAL MEMBER

Shoot targets ONLY and practice at any ACTA club. **Duration of membership**
Registered Shooting Memberships of the following variations may be offered by the Company, the Member States and Clubs:

- (a) Each membership is due for renewal the 31st of December each calendar year

4. **RENEWAL OF REGISTERED SHOOTING MEMBERSHIP**

When the expiration of a Member's Registered Shooting Membership is approaching, or has passed, they may re-apply to be granted a new Registered Shooting Membership. This application is not a renewal of the prior membership and is a new membership application, to be treated as such under the Company's Constitution.

5. **REGISTERED SHOOTING MEMBERS REVIEW**

The Board may review and amend process and system regarding the categories, granting and renewal of registered shooting memberships on an annual basis.
